1) In this first revision, the following changes have been made: a) Reference clause has been updated; b) Construction clause has been modified; c) New requirement and method of test for Print resistance and ink adhesion of printed cartons has been incorporated; d) Cobb 60 Second requirement has been removed; e) Requirements for thickness, grammage, bulk, moisture, Stiffness, brightness, gloss, IGT dry pick and roughness have been updated; f) Bendtsen smoothness requirement has been specified for material when bottom is coated or uncoated, and g) The optional requirement for ECO mark has been deleted.

Please examine the document and share your comments regarding further improvement in the document.
