*This document has following salient features which may require specific attention for your valuable comments:*

*1) Sodium saccharin is a non-nutritive sweetener. It is taken by diabetics and those who need low calorie diet as a substitute for cane sugar. It is about 500 times sweeter than sugar. Use of sodium saccharin, food grade as artificial sweetener has been permitted in selected food items under the Food Safety and Standards (Food Products Standards and Food Additives) Regulation, 2011.*
