It complements the existing requirements of IS/ISO/IEC 17021-1. In particular, it clarifies the requirements for the competence of personnel involved in the certification process set out in IS/ISO/IEC 17021-1:2015, Clause 7 and Annex A.

Certification bodies have a responsibility to stakeholders, including their clients and the customers of the organizations whose management systems are certified, to ensure that only those auditors who demonstrate the relevant competence are permitted to conduct management system audits. Personnel certifying the management systems for quality in healthcare organizations must possess the generic competencies described in IS/ISO/IEC 17021-1, as well as the specific competencies described in this Part 15 document.
