### **Subject: Guidelines for implementation of Revised IS 1912:2023 (Textiles — Country Jute Twine — Specification)**

1. IS 1912:1984 has been revised as IS 1912:2023 and has been published. The last date for implementation of the revised Standard is **19 May 2023** after which the old Standard shall stand withdrawn.
2. KKBO-II shall inform the sole licensee M/s AI CHAMPDANY INDUSTRIES LTD about implementation of the revised Standard immediately. Although there are currently no applications, BOs which receive any applications subsequently shall also inform the applicants accordingly.
3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Change
6.2	Requirement for identification of material has been incorporated;
4	Atmospheric conditions for conditioning and testing are specified in this standard
5.5	The test method for measuring the lubricant in the twine has been specified;
9	Marking clause has been modified: Variety of the twine, Number of plied, Month and Year of manufacture (instead of only year), Any other information required by the law in force and/or by the buyers added to the requirements to be marked on each bale
2	References to Indian standards have been updated.

4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately.
5. The guidelines for implementation of the revised Standard is given below:

#### **A. LICENSEES:**

- i. The licensee shall implement the revised Standard by **19 May 2023**. **Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest.** BOs shall ensure that no Licences are under operation as per the old Standard after **19 May 2023**. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.**

- ii. The licensee shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports. Verification of implementation of the revised Standard, wherever required, **shall be verified through a surveillance visit within 30 days of confirmation of implementation of the revised standard by licensee.**
- iii. If the Licensee fails to complete all actions by **19 May 2023** it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- ii. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only up to **18 May 2023** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **19 May 2023**.
- iii. Beyond **19 May 2023** no Licence shall be granted as per the old Standard.

**C. CHANGE IN SCOPE OF LICENCE:**

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
  - ii. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **19 May 2023** whichever is earlier.
6. The above guidelines come into force with immediate effect.
