Subject: Guidelines for implementation of Amendment no. 2 to IS 1061 : 2017, DISINFECTANT FLUIDS, PHENOLIC TYPE

1. Amendment no 2 to IS 1061 : 2017 has been published.
2. The product is under voluntary certification. There are 47 licences for the product and 1 pending application for GOL in India.
3. IS 1061 : 2017 is under concurrent running with and without amendment no 2 to the IS, till 30th June 2024. The last date for implementation of the amendment is 30th June 2024
4. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Sl no	Clause No	Change
1.	Page 4, clause B-2.2;	Note under the clause has been replaced and in the note, IMTECH Chandigarh or ATCC approved labs has been included in the list of institutes for sourcing the cultures required in the tests
2.	Page 7, clause C-2.2	Note under the clause has been replaced and in the note, <i>ATCC approved labs</i> has also been included in the list of institutes for sourcing the cultures required in the tests.

5. The existing Product manual has been revised to incorporate the changes due to the amendment to the IS and it is being circulated separately, through BIS website, as Product Manual Doc: **PM/1061/2 Feb 2024**
6. Through the amendment both IMTECH Chandigarh and ATCC approved labs have been covered in the list of institutes from where cultures of both *Salmonella typhi* and *Staphylococcal aureus* can be sourced.
7. The change in the IS with the amendment is non- technical in nature and does not require any evidence of conformity to establish compliance to the amendment, and therefore no confirmation of implementation of the amendment by licensee is solicited.
8. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
9. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 30th June 2024.
10. The above guidelines come into force with immediate effect.
