Subject: Guidelines for implementation of amendment no. 5 to IS 17261:2022 (Textiles - Polyester continuous filament fully drawn yarns - Specification)

1. Amendment no. 5 to IS 17261:2022 has been published. The last date of implementation of the amendment is **3 April 2024**.

2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
8.1 (a)	In the marking clause 'Name and description of the material;' has been substituted <i>for</i> 'Name and description of the material (see 5.2);' i.e. reference to Cl. 5.2
8.1 (b)	In the marking clause 'Designation of the material;' has been substituted <i>for</i> 'Designation of the material (see 5.1)'

3. Since the changes through the amendment are only editorial, no evidence of conformity to the amended standard needs to be submitted by licensees/applicants.

4. BOs shall communicate the implementation of the amendment immediately to licensees/applicants within 7 days of this circular.
