Subject: Guidelines for implementation of revised IS 3564:2025 - ‘Hydraulically Regulated Door Closers’

1. IS 3564:1995 and IS 14912:2001 have been amalgamated and revised as IS 3564:2025, and has been published. The last date for implementation of the revised Standard is **20 May 2026** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard **within a week of issuance of these guidelines**.
3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Sr No	Major changes in revised Indian Standard	Action required from licensee end
1.	Both IS 3564:1995 (surface mounted door closers) and IS 14912:2001 (Concealed type door closers) have been amalgamated and revised as IS 3564:2025 (Door Closers). (Clause 1)	For the manufacturers having licence only as per IS 3564:1995 or as per IS 14912:2001, the Licence will be changed over to IS 3564:2025. For manufacturers having licences both as per IS 3564:1995 and IS 14912:2001, the licence as per IS 3564:1995 will be changed over to IS 3564:2025 and the other licence as per IS 14912:2001 will be cancelled.
2.	Classification system of door closers have been modified. Mechanism of door closer, mounting arm and classification code has been included in the classification of door closers. Fire rated and for doors weighing upto 160 kg has been added. (Clause 4 & 8)	Manufacturers shall declare the varieties of door closers within their existing licence scope as per the revised classification. Subsequently, BO shall review the declaration and modify the scope of licence as per the modified classification system mentioned in revised product manual. In case, manufacturers intend to cover the varieties which are beyond their existing licence scope, then provision of CSoL shall be followed.
3.	Various additional performance requirement, such as power size and efficiency, fire resistance, corrosion resistance have been added. (Clause 9.4, 9.5, 9.7)	Manufacturers are required to submit evidence of compliance to these additional performance requirements through in-house or independent test report, as applicable
4.	Test method of durability and operation at extreme Temperatures have been modified. (Clause 9.3 & 9.8)	Manufacturers are required to submit evidence of compliance to these performance requirements through in-house or independent test report, as applicable

5.	Marking Clause has been modified. (Clause 11)	Confirmation from manufacturer is required.

4. Consequent upon the issuance of the revised Standard, existing Product Manual has been revised as Doc: **PM/IS 3564/2/Mar 2026**.

5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

(i) All Licensees shall implement the revised Standard by **20 May 2026**. Any difficulty in the implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no licences are in operation as per the old Standard after **20 May 2026**. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

(ii) In order to implement the amendment, manufacturers shall submit the following:

- For the manufacturers having licence only as per IS 3564:1995 or as per IS 14912:2001, the Licence will be changed over to IS 3564:2025. For manufacturers having licences both as per IS 3564:1995 and IS 14912:2001, the licence as per IS 3564:1995 will be changed over to IS 3564:2025 and the other licence as per IS 14912:2001 will be cancelled.
- Manufacturers shall declare the varieties of door closers within their existing licence scope as per the revised classification. Subsequently, BO shall review the declaration and modify the scope of licence as per the modified classification system mentioned in revised product manual. In case, manufacturers intend to cover the varieties which are beyond their existing licence scope, then provision of CSoL shall be followed.
- Manufacturers are required to submit evidence of compliance to all the performance requirements as per Clause 9 of IS 3564:2025, through in-house or independent test report, as applicable.
- Confirmation from manufacturer w.r.t. the modified marking requirements is required.

(iii) On receipt of confirmation on the implementation of IS 3564:2025 from the manufacturer, endorsement shall be issued with revised scope of licence as per the revised Product Manual.

(iv) Verification of implementation of the revised Standard shall be done through a surveillance visit, which shall be completed within three months from the date of implementation.

(v) If the Licensee fails to complete all actions by **20 May 2026**, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **20 May 2026** and for such cases, Applicant shall give a declaration that they will implement the revised Standard by **20 May 2026**.
- (iii) Beyond **20 May 2026** no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **20 May 2026** whichever is earlier.

6. The above guidelines come into force with immediate effect.
