This has reference to the subject mentioned above.

IS 6218: 2008 was revised as IS 6218: 2025. The guidelines for implementation of the above-mentioned revision was circulated vide note no. CMD-3/16: IS 6218: 2025 dated 26 November 2025. The last date of implementation of the revised Standard was 24 January 2026.

In view of the requests received from manufacturers, the concurrent running of IS 6218: 2008 and IS 6218: 2025 and the last date of implementation of IS 6218: 2025 has now been extended up to **24 January 2027**. All BOs may bring it to the notice of all Licensees and Applicants and ensure implementation of revised Standard by **24 January 2027**.

The other provisions of implementation laid down in circular no. CMD-3/16: IS 6218 dated 26 November 2025 shall remain the same.
