Subject: Guidelines for implementation of Revised IS 1507:2024 (Copper Oxychloride Water Dispersible Powder Concentrate —Specification)

1. This has reference to the above.
2. IS 1507:1977 has been revised as IS 1507:2024 and the date of withdrawal of IS 1507:1977 is **09th April 2025**.
3. Presently, for IS 1507:1977, 02 licences are operative domestically.
4. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

2 References	A new clause listing the referred standards has been added and subsequent clauses have been renumbered. Further, the latest versions of the referred standards have been updated
5 Marking	<p>Marking clause has been slightly modified to specify that the containers shall be securely closed and shall bear legibly and indelibly the information specified.</p> <p>Date of Expiry has been added in the information to be marked.</p> <p>Cautionary Note earlier specified has been replaced with Cautionary notice as worded in the <i>Insecticides Act</i>, 1968, and rules framed thereunder.</p> <p>Requirement of Pictorial marking on Bags has been omitted.</p>

5. Consequent upon the issuance of the revised Standard, the existing product manual of IS 1507 has been revised which is being circulated separately.
6. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

i) All Licensees shall implement the revised Standard by **09th April 2025**. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest but in any case at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per old Standard after **09th April 2025**. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.**

ii) As per the changes introduced into the standard through the revision, there are no evidences of conformity required to be submitted by the licensees.

iii) **Earlier no Grouping Guidelines were prescribed. In the revised Product Manual of IS 1507, Grouping Guidelines based upon nominal Copper Content(m/m) of Copper Oxychloride Water Dispersible Powder Concentrate have been specified and range of Copper Content(m/m) of Copper Oxychloride Water Dispersible Powder Concentrate has been added as a part of Scope of Licence.**

iv) **Licensees shall declare the range of Copper Content(m/m) of Copper Oxychloride Water Dispersible Powder Concentrate being manufactured by them and submit in-house test reports as per Grouping Guidelines.**

v) BOs shall revise the scope of licence based upon declaration of range of Copper Content(m/m) of Copper Oxychloride Water Dispersible Powder Concentrate submitted by the firm and issue endorsement for revised scope of licence along with switchover to revised IS 1507:2024.

B. APPLICATIONS FOR GRANT OF LICENCE:

1. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
2. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **08th April 2025** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **09th April 2025**.
3. Beyond **09th April 2025** no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

1. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
2. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to **09th April 2025** whichever is earlier.

3. The above guidelines come into force with immediate effect.
