Subject: Guidelines for implementation of revised IS 8028:2023 for Quinalphos Emulsifiable Concentrate — Specification to IS 8028:1987 for Specification for Quinalphos EC

1. IS 8028:1987 has been revised as IS 8028:2023 for Quinalphos Emulsifiable Concentrate — Specification and has been published. The last date for implementation of the revised IS 8028:2023 is **15th August 2023**, after which the old standard (IS 8028:1987) shall stand withdrawn.
2. As on date there is only 01 licence for IS 8028:1987 which is operational under NGBO.
3. The significant changes in the standard through this revision as listed in the Table are given below for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

Clause No. of IS 8028:2023	Changes
5.1 (Marking)	Requirement of the following information to be marked on each container, has been modified: a) 'Net mass of contents' has been modified as 'Net quantity'; Following information is to be additionally marked on each container: a) Address of the manufacturer b) Date of expiry c) Any other information required under the Legal Metrology (Packaged Commodities) Rules, 2011

4. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/8028/2, July 2023.
5. The guidelines for implementation of the revised IS are as given below:

A. LICENSEES:

- (i) Since the changes in the revised standard are only in the marking requirements, it does not require any evidence of conformity to be submitted, as per the revised Indian Standard. However, BOs are requested to circulate the revised standard to the licensee and applicants, within 7 days of issue of this circular.
- (ii) BO shall ensure that the Licence is not under operation as per IS 8028:1987 (old standard) after **15th August 2023**. The status of implementation of the revised Indian Standard, shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (iii) The licensee shall confirm compliance to the modified marking requirements by **15th August 2023**.

- (iv) If the Licensee fails to complete all actions by **15th August 2023**, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto **15th August 2023**. For such cases Applicants shall give a declaration that they will implement the revised Standard by **15th August 2023**.

6. The above guidelines come into force with immediate effect.
