Subject: Guidelines for implementation of Amendment No. 1 to Indian Standard IS 12300: 2024- Gas Cylinder Valves for Small Refrigerant Cylinders

- 1. Amendment No. 1 to IS 12300: 2024 has been published. The last date for implementation of the Amendment is 21 October 2025.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment within a week of issuance of these guidelines.
- **3.** The significant changes brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BOs shall, however, ensure that the product conforms to all the requirements, as applicable, of the Standard read along with its Amendment.

- 4. Consequent upon issuance of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 12300/3/ September 2025. In this revision, number of Amendments has been updated and provision to use material with prior permission of statutory authority has been incorporated in Scheme of Inspection and Testing, as per the Amendment.
- 5. Prior approval of statutory authority is always required for Grant of BIS licence as well as inclusion of new variety in existing BIS licence and is already given by PESO for all such licences. Therefore, no change in manufacturing and testing facilities is required for existing licensees in order to implement the Amendment, neither any evidence of conformity is required to be submitted for implementation of the Amendment.
- 6. The above guidelines come into force with immediate effect.
