Subject: Guidelines for implementation of Amendment No. 3 to Indian Standard IS 1341: 2018 – Steel Butt Hinges — Specification.

- 1) Amendment No. 3 to IS 1341 has been published. **The last date for implementation of the Amendment is 24 December 2026.**
- 2) All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment **within a week of issuance of these guidelines.**
- 3) The significant changes brought out in the Standard through the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Sr No.	Major Changes in Amendment to Indian Standard
1.	Classification based on construction has been introduced, namely Plain Joint Hinges, Washer Hinges and Bearing Hinges, in addition to the existing classification based on types. (Clause 3)
2.	Material requirements have been revised. Additional Indian Standards for flap and pin materials have been included, and use of other steel materials has been permitted by mutual agreement between the manufacturer and purchaser, subject to declaration of the applicable Indian Standard and grade. (clause 4)
3.	Provision has been introduced for manufacture of any other dimensions, that is, combination of length, breadth, thickness of the flap and diameter of the pin, by agreement between manufacturer and purchaser, subject to specified minimum requirements of thickness of the flap and diameter of the pin, and declaration of number and position of screw holes Manufacturing tolerances for any other dimensions and a manufacturing tolerance of –0.05 mm for flap thickness specified as C Min, from Table 2 to Table 9, have been introduced. (Clause 5.3)
4.	For any other dimensions, that is, combination of length, breadth, thickness of the flap and diameter of the pin, the minimum number of knuckles is to be declared by the manufacturer. (Clause 6.2.2)
5.	The existing Finish requirements have been replaced with Corrosion Resistance and Finish requirements. Corrosion resistance grades (Grade 0 to Grade 4) based on Neutral Salt Spray Test as per IS 5528 have been introduced along with corresponding corrosion resistance requirements. (Clause 7)
6.	Packing and marking requirements have been revised. Package marking shall now include the following – a) Manufacturer's name or brand name or trade name; b) Construction and type of hinges; c) Dimensions of hinges, that is, length, breadth and thickness of flap; d) Corrosion resistance grade;

	e) Grade and IS of material (both flap and pin); and f) Quantity of hinges.’ (Clause 9)
7.	Manufacturer's instruction leaflet (Annex C) has been deleted.

4) In order to implement the amendment, licensees shall submit

i) A revised Scope declaration, as per the revised Product Manual, including the classification of steel butt hinges based on construction and grades for corrosion resistance.

ii) In-house/ independent test report as evidence of conformity to Clause 7 (CORROSION RESISTANCE AND FINISH)

iii) Indicating the arrangement for testing of additional requirements as per Clause 7 (CORROSION RESISTANCE AND FINISH)

- In-house/ outside.

iv) Compliance with the Packing and marking clause.

5) BOs shall examine the declarations submitted by the licensees, modify the scope of the licence in line with the revised Product Manual, and issue the necessary endorsement accordingly.

6) Consequent upon issuance of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 1341/4/August 2026.

7) No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 24 December 2026.

8) The above guidelines come into force with immediate effect.
