Subject: Guidelines for implementation of Amendment No. 1 to IS 2418 (Part 2): 2018 'Tubular fluorescent lamps for general lighting service: Part 2 performance requirements (Second Revision)'

- 1. Amendment No. 1 has been published for IS 2418 (Part 2): 2018 'Tubular fluorescent lamps for general lighting service: Part 2 Performance requirements (Second Revision)'. The last date of concurrent running of IS 2418 (Part 2): 2018 with and without Amendment No. 1 is 01 August 2024.
- 2. Currently there are 3 licences for the product. In this regard, the concerned branch Offices, i.e. **NOBO** and **VDBO** shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. Any difficulty in the implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines.
- 4. The significant changes brought in the Indian Standard through the Amendment listed in the Table below. NOBO and VDBO are requested to ensure the compliance of the requirements as specified in the amended Indian Standard.

- 5. The duration of test in Cl. 7.8.3 is increased through the Amendment No. 1. Further, as the test is already indicated in Scheme of Inspection and Testing in the Product Manual 'PM/ IS 2418 (Part 2)/ 1/ June 2020', no changes have been made in the Product Manual of the Indian Standard. However, going forward, the no. of Amendments indicated in the Product Manual may be read as '1'.
- 6. The guidelines for implementation of the Amendment is given below:

#### A. For Licensees:

- (i) In order to establish conformity to modified requirements, licensees shall submit the inhouse/independent test report of product for the required test, as evidence of conformity to the IS 2418 (Part 2): 2018 including Amendment No. 1.
- (ii) BOs shall ensure that no Licences are under operation without the implementation of the Amendment No. 1 after 01 August 2024.
- (iii) If the Licensee fails to complete all actions by 01 August 2024, necessary actions may be initiated.

### **B. For Applicants:**

- (i) Currently, there is no applications as per IS 2418 (Part 2): 2018.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment.
- (iii) Processing of Applications without consideration of the amendment shall be permitted only upto 01 Aug 2024 and for such cases Applicant shall give a declaration that they will implement the amendment by 01 Aug 2024.

#### **C. For Inclusions:**

- (i) Existing provisions for Inclusion shall apply.
- 7. The above guidelines come into force with immediate effect.
