Subject: Guidelines for implementation of Amendment no. 3 to IS 5158:1987 – (Phthalic anhydride, technical)

- 1. Amendment no. 3 to IS 5158:1987 has been published. The amendment shall be implemented with effect from **12 July 2023.**
- All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The amendment has been issued only to modify the requirement with respect to the certificate for the thermometer to be used for testing as per test method given in Appendix A (A-2.1.3.1). Whereas earlier it was specified that the thermometer shall bear a certificate from the National Physical Laboratory, New Delhi or any other institution authorized by the Government of India to issue such a certificate, this has been changed through the amendment to state that:

"The thermometer shall bear a valid calibration certificate from any institution authorised to issue calibration certificate traceable to international or national measurement standards."

- 4. There is no change required in the existing product manual/SIT on account of this amendment.
- 5. Licensees and applicants shall be informed about this change through the amendment and advised to confirm compliance at the earliest. Compliance shall be verified during the subsequent factory visit.
- 6. Beyond 12 July 2023 no Licence shall be granted without consideration of the amendment.
- 7. The above guidelines come into force with immediate effect.
