**Subject: Extension of the period of concurrent running of IS 2415: 2015 and IS 2415: 2025-
“Cycle- Rubber Tubes (Moulded/ Jointed)”**

This has reference to the subject mentioned above.

IS 2415: 2015 was revised as IS 2415: 2025. The last date of implementation of the revised Standard was 10 July 2026.

In view of certain anomalies in the revised Standard and subsequent request received from manufacturers, the concurrent running of IS 2415: 2015 and IS 2415: 2025 and the last date of implementation of IS 2415: 2025 has now been extended up to **10 July 2026**. All BOs may bring it to the notice of all Licensees and Applicants and ensure implementation of revised Standard by **10 July 2026**.

An Amendment addressing these anomalies is under consideration with BIS technical department TED and is likely to be published in the month of March 2026. Once the Amendment is issued, the same will be informed to all BOs for taking necessary actions.
