# Subject: Revised Product Manual for IS 2082 : 2018 'Stationary Storage Type Electric Water Heaters (Fifth Revision)'

- 1. This has reference to the subject mentioned above.
- 2. The Product Manual for IS 2082 : 2018 'Stationary Storage Type Electric Water Heaters (Fifth Revision)' has been revised and hosted on the BIS website under

# "Conformity Assessment $\rightarrow$ Product Certification $\rightarrow$ Product Specific Guidelines $\rightarrow$ Product Manual.

- 3. The following changes have been made in the Product Manual:
  - a) Model No. has been added in the scope of licence.
  - b) The grouping guidelines have been changed.
- 4. Consequently, the existing Product Manual and SIT has been revised as of the revised Standard, existing STI has been revised as Doc: **PM/IS 2082/4/January 2023**.
- 5. The guidelines for implementation of the Product Manual are as given below:

#### **B.** For Existing Licensees:

- i. Licencees shall submit a declaration for each model as per revised scope of licence for all the existing varieties covered in their scope of licence as on date. Based on the above declaration, BOs shall revise the existing scope of licence and issue endorsement.
- ii. Verification of the same shall be done through a special inspection/ surveillance inspection after the submission of compliance by the licensee or latest by six months from the date of issue of the circular.
- iii. If the Licensee fails to complete all actions by six months from the date of issue of the circular, necessary actions may be initiated.

### **B.** For Applicants:

- i. For existing Applications where sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory, a declaration as per the revised scope of licence may be taken from the applicant. Further, scope of the licence may be limited as per the grouping guidelines in the Product Manual.
- ii. Applications which are recorded henceforth may be processed with the revised scope as per the Product Manual.

### **C. For Inclusions:**

- i. For Inclusion of new varieties, the relevant provisions as given above for Applicants shall apply.
- 6. The above guidelines come into force with immediate effect. All BOs shall inform the Applicants and Licensees under their jurisdiction about the revised Product Manual immediately.
