7Subject: Revised Product Manual for IS 302-2-80 : 2018 ‘Household and similar electrical appliances - Safety: Part 2 - 80 particular requirements for fans (First Revision)’

1. This has reference to the subject mentioned above.
2. The Product Manual for **IS 302-2-80 : 2017 - ‘Household and similar electrical appliances - Safety: Part 2 - 80 particular requirements for fans (First Revision)’** has been revised and hosted on the BIS website under

“Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual.

3. The following changes have been made in the Product Manual:
 - a) Following Note has been added in the PM:

“In case a manufacturers is already having a valid licence for ceiling fans as per IS 374 : 2019, then for those varieties which are in the scope of licence, the requirements for IS 302-2-80 : 2017 shall be deemed to be complied. Further, the manufacturer shall not be required to take separate licence as per IS 302-2-80 : 2017 for these varieties.
For other types of fans, i.e. Duct fans; Partition fans; Pedestal fans; Table fans; other fans, manufacturer has to get BIS licence as per IS 302-2-80 : 2017.”
 - b) Scope of the licence has been modified to include other types of fans;
 - c) List of equipment has been updated;
 - d) SIT has been updated as per latest format.
4. Consequently, the existing Product Manual and SIT has been revised as Doc: **PM/IS 302-2-80/2/July 2024.**
5. The above guidelines come into force with immediate effect. All BOs shall inform the Applicants and Licensees under their jurisdiction about the revised Product Manual immediately.
