Subject: Guidelines for implementation of Amendment No. 2 to Indian standard IS 17566: 2021- Key Locks for Security Equipment

1. Amendment No. 2 to IS 17566: 2021 has been published. The last date for implementation of the Amendment is **08 February 2026**.
2. BOs shall inform the Licensees under their jurisdiction about implementation of the Amendment **within a week of issuance of these guidelines**.
3. The significant changes brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BO shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

1.	Page 3, Cl. 8.3.1- Salt spray Corrosion test method	Test method for Salt spray Corrosion test has been modified.

4. Consequent upon issuance of the Amendment, existing Product Manual has been revised as Doc: PM/ IS 17566/ 4/ November 2025. In this revision, changes have been made in Scheme of Inspection and testing.
5. The guidelines for implementation of the Amendment is given below:

A. LICENSEES:

- (i) Licensee shall implement the Amendment by 08 February 2026. **Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines.** BO shall ensure that no Licences are under operation without Amendment after 08 February 2026. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) In order to establish conformity to modified requirements, licensees shall submit test report, in-house or independent, as applicable of product indicating conformity to modified requirements (as per Cl. 8.3.1).
- (iii) Verification of implementation of the Amendment, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee.
- (iv) If the Licensee fails to complete all actions by 08 February 2026, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been tested may be processed without considering Amendment. However, if the Applicant is desirous of considering the application with Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, Licence will not be granted without Amendment.
- (ii) Applications which are recorded henceforth may be processed with or without Amendment. Processing of Applications without Amendment shall be permitted only up to 08 February 2026 and for such cases Applicant shall give a declaration that they will implement the Amendment by 08 February 2026.
- (iii) Beyond 08 February 2026 no Licence shall be granted without consideration of the Amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
 - (ii) However, processing of such applications for change in scope of licence without Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 08 February 2026 whichever is earlier.
6. The above guidelines come into force with immediate effect.
