Subject: Guidelines for implementation of Revision of IS 17155: 2025 – Tricycle, Single Hand Propelled (Right/Left) (Junior Size)

1. IS 17155: 2019 has been revised to IS 17155: 2025 and the last date of concurrent running of the Standard with and without Revision is 24 Jan 2026.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Revision of IS 17155: 2025 within **a week of issuance of these guidelines**.
3. The revision of this standard has been brought out to incorporate the revised cross references and revised grades of material referred in the standard. However, the changes brought through the revision is tabled below:

4. Consequent upon the revision of Indian Standard, the Product Manual has been revised as Product Manual Doc: **PM/ IS 17155/ 2/ Dec 2025** and is being circulated separately through BIS website.
5. The guidelines for implementation of revision of IS 17155: 2025 is given below:

A) LICENSEES

- i. Licensee shall implement the requirements of revision of IS 17155: 2025 by 24 Jan 2026. Any difficulty in implementation of revised standard shall be brought to the notice of CMD III within one month of issuance of these guidelines. BO shall ensure that no Licences are under operation without revised standard after 24 Jan 2026. The status of implementation of the revision of IS 17155: 2025 shall be confirmed by Head (BO) to CMD-III within one month of the last date of concurrent running.
- ii. Firm shall submit the declaration w.r.t tube, grade of erw and type of finish of metallic parts. Further, the firm shall submit the conformity of other requirements either through test certificate issued from BIS approved labs or the materials used shall be ISI marked.
- iii. Verification of implementation of the revised IS 17155: 2025 shall be done during the next surveillance visit, which shall be completed within one month from the date of submission of compliance by licensee.
- iv. If the Licensee fails to complete all actions by 24 Jan 2026, it shall be dealt with as per the prevailing guidelines.

B) APPLICATIONS FOR GRANT OF LICENCE

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of revised IS 17155: 2025. However, if the Applicant desires to get the licence with revised standard, a declaration may be obtained from the Applicant to that effect, and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revision to IS 17155: 2025, Licence will not be granted without considering revision to IS 17155: 2025.
- ii. Applications which are recorded henceforth may be processed with or without considering revision to IS 17155: 2025. Processing of Applications without considering revision to IS 17155: 2025 shall be permitted only up to 24 Jan 2026 and for such cases Applicant shall give a declaration that they will implement the revision to IS 17155: 2025 by 24 Jan 2026.

iii. After 24 Jan 2026, no Licence shall be granted without consideration of revision to IS 17155: 2025.

6. The above guidelines come into force with immediate effect.
