Subject: Guidelines for implementation of Amendment no. 1 to IS 6603 – (Stainless Steel Bars and Flats)

1. Amendment no. 1 to IS 6603 has been published. The amendment shall be implemented with effect from **01st February 2024**.

2. The significant changes in the standard through this amendment as listed in the Table are given below.

Clause	Change
9.1, Mechanical Properties	The clause has been amended by adding that the tensile properties of grades and/or conditions which are not specified in Tables 3 to 8 shall as agreed to between the manufacture and purchaser

4. No change in the existing Product Manual is required on account of this amendment.

5. Since as per the amendment it has only been clarified that the tensile properties of grades and/or conditions which are not specified in the relevant Tables are permitted to be as agreed to be between the manufacturer and purchaser, all BOs are requested to circulate this amendment for the information of all licensees and applicants under the jurisdiction within a week of issuance of these guidelines.

6. Any issues faced with regards to the implementation of the amendment may kindly be brought to the notice of CMD-2 at the earliest and not more than 30 days before the last date of implementation of the amendment please.
