Subject: Guidelines for implementation of Amendment No. 2 to Indian Standard IS 2061: 1995- Bicycle Front Forks

1. Amendment No. 3 to IS 2061: 2008 has been published. **The last date for implementation of the Amendment is 03 April 2024.**
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment **within a week of issuance of these guidelines.**
3. The significant changes brought through this Amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

Sl. No.	Page and Clause reference	Changes
1.	Part 1, Cl. 4- <i>Dimensions and tolerances of forks</i>	Compliance of dimensions and tolerances of the forks to Fig. 1 (of IS 2061) and IS 2039 (Part 1 to 3), has now been made optional instead of mandatory.

4. Consequent upon issuance of the Amendment, no change in manufacturing and testing facilities will be required for existing manufacturer licensees or applicants. Also, no evidence of conformity will be required to be submitted by the licensees, as compliance to the Amendment.
5. Consequent upon issuance of the Amendment to the Standard, existing Product Manual has also been revised as Doc: PM/ IS 2061/3/ February 2024. In this revision, changes have been made in provisions of Possible tests in a day and Scheme of Inspection and Testing.
6. The above guidelines come into force with immediate effect.
