Subject: Guidelines for implementation of Amendment No. 2 to IS 7098 (Part 2): 2011 'Cross-linked Polyethylene Insulated Thermoplastic Sheathed Cables for working voltages from 3.3kV up to and including 33kV'

- 1. Amendment No. 2 has been notified against IS 7098 (Part 2): 2011 'Cross-linked Polyethylene Insulated Thermoplastic Sheathed Cables for working voltages from 3.3kV up to and including 33kV'. The last date of concurrent running of the Standard without Amendment No. 2 is 12 January 2023.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about the implementation of the amendment.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon the publication of the Amendment to the Standard, the existing Product Manual and SIT has been revised as of the revised Standard, existing STI has been revised as **Doc: PM/IS/ 7098 (Part 2) / 2/ June 2022**
- 5. The guidelines for implementation of the Amendment is given below:

A. For Licensees:

- (i) All Licensees shall implement the requirements of Amendment No. 2 to IS 098 (Part 2): 2011 by 12 January 2023. BOs shall ensure that no Licences are under operation without the implementation of the Amendment after 12 January 2023.
- (ii) Licensees shall confirm conformance to the additional/modified requirements through Inhouse/ Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the Amendment, shall be done through a special inspection/ surveillance inspection after the submission of compliance by the licensee or latest by three months from the last date of concurrent running.
- (iii) If the Licensee fails to complete all actions by 12 January 2023, necessary actions may be initiated.

B. For Applicants:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory without the implementation of the Amendment No.2, may be processed without considering the Amendment No. 2. However, if the Applicant is desirous of considering the Application as per the requirements of Amendment No. 2 as well, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS.
- (ii) Applications which are recorded henceforth may be processed with or without considering the Amendment No. 2 to the Standard. For such cases where the Application is processed without considering the Amendment No. 2, Applicant shall give a declaration that they

implement the requirements of the Amendment by 12 January 2023.

(iii) Beyond 12 January 2023, no Licence shall be granted without considering Amendment 2 to IS 7098 (Part 2): 2011

C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without considering the Amendment No. 2 to the Standard shall be permitted only upto the last date of concurrent running, i.e. 12 January 2023.
- 6. The above guidelines come into force with immediate effect.
