**Subject: Guidelines for implementation of Amendment No. 2 to Indian Standard IS 16192 (Part 3): 2018- Automotive Vehicles - Wheel Rims For Two And Three Wheeled Vehicles: Wired Spoke Wheel Rims - Method Of Tests and Requirements**

1. Amendment No. 2 to IS 16192 (Part 3): 2018 has been published. **The last date for implementation of the Amendment is 28 May 2025.**
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment **within a week of issuance of these guidelines.**
3. The significant changes brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

Sl. No.	Page No, Clause reference	Change
1.	Cover Page, Title of Standard	Title of Standard has been clarified to specify that the Standard is for Wired spoke wheel Rims.
2.	Page 1, Cl. 1- Scope of standard	Type of vehicle for which the wheel rims are covered in the Standard have been specified now.
3.	Page 1, Cl. 4.2.2- Strength requirements-	It has now been specified that for Rim sizes which are not listed in Table 1 and Table 2 of the Standard, load value and deflection value shall be declared by the manufacturer as per Cl. 4.2.2 of IS 16192-3.
4.	Page 1, Cl. 4.3- Rim Contour	New clause has been added to provide various Rim contours (for reference purpose only).

4. Consequent upon issuance of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 16192 (Part 3)/3/ February 2025. In this revision, changes have been made in Grouping Guidelines and Scheme of Inspection and Testing as per the Amendment. Also, declarations to be made in test request of a sample has been incorporated in the Manual
5. No change in manufacturing and testing facilities is required for implementing the Amendment for licensees. No evidence of conformity is required to be submitted. New varieties which are now permitted through this Amendment, shall be covered through the process of change in scope of licence (inclusion) or Grant of licence, as applicable.
