**Subject: Guidelines for implementation of IS 7933 : 2022 (including amendment no. 1) Flexible Polyurethane Foam for Domestic Mattresses - Specification**

1. IS 7933 : 1975 has been revised and published as IS 7933 : 2022. Amendment no. 1 to IS 7933 : 2022 has also been published. The last date for implementation of the revised Standard is **27 October 2022** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
3. The significant changes in the revised Standard as listed below are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard (including amendment no -1) .

Clause	Change
2	References to the referred Standards have been updated
3	Now two commonly used polyurethane foams in mattresses (Type 1 and Type 2) have been covered and their requirements have been specified.
5.4	Tolerances on length, width and thickness have been changed.
5.8	Requirement of density have been changed and given for core, comfort and quilting layers separately.
6.2	Marking clause has been modified

4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately as **PM/ 7933/ 3 September 2022**.
5. The guidelines for implementation of the revised Standard (including amendment no. -1) are given below :

**A. LICENSEES :**

- (i) All Licensees shall implement the revised Standard by **27 October 2022**. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest. BOs shall ensure that no Licences are under operation as per old Standard after **27 October 2022**. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports. Verification of implementation of the

revision (including amendment no – 1), shall be verified through a surveillance visit within 30 days of confirmation of implementation of the revised standard by licensee.

- (iii) BOs shall issue the endorsement for revised scope and existing variety would be endorsed as Type 1 as per IS 7933 : 2022, after receipt of conformity as per the revised standard. Type 2, can be included in the scope, as per guidelines for change in scope of the licence.
- (iv) If the Licensee fails to complete all actions by 27 October 2022 it shall be dealt with as per the prevailing guidelines.

#### **B. APPLICATIONS FOR GRANT OF LICENCE :**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard (including amendment no- 1). Processing of Applications as per the old Standard shall be permitted only upto 27 October 2022 and for such cases Applicant shall give a declaration that they will implement the revised Standard (including amendment no. – 1) by 27 October 2022.

(iii) Beyond 27 October 2022 no Licence shall be granted as per the old Standard.

#### **C. CHANGE IN SCOPE OF LICENCE:**

- i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto 27 October 2022 whichever is earlier.

6. The above guidelines come into force with immediate effect.
