Subject: Guidelines for implementation of Amendment no. 2 & 3 to IS 15748 : 2022 (Protective clothing – Clothing to Protect Against Heat and Flame – Minimum performance requirements)

1. Amendment no. 2 & 3 to IS 15748: 2022 has been published. The last date of implementation of the amendments are **29th March 2025 and 23rd June 2025 respectively**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change incorporated through Amendment no. 2
National Foreword	Following new paragraph has been added after paragraph 4 of National Foreword: 'Clause 6.4 has been modified for better clarity and the modified clause is given in National Annex B.'
National Annex A	National Annex B has been added after National Annex A wherein clarity has been provided that the dimensional change shall be measured after the samples have undergone five cleaning cycles according to 5.2.1.

Clause No.	Change incorporated through Amendment no. 3
National Foreword	Following new paragraph has been added after paragraph 5 of National Foreword: 'Clause 4.2.2 has been modified for better clarity and the modified clause is given in National Annex C.'
National Annex A	National Annex C has been added after National Annex B wherein clarity has been provided that the Suits shall consist of one of the following: a) a single garment, for example, a coverall or boiler suit; b) a two-piece garment, consisting of a jacket and a pair of trousers. Further, the requirements pertaining to single garment and two-piece garment suits have been specified clearly.

3. All the changes to the standard through this amendment are editorial, none of which require any evidence of conformity to the amended standard to be established. **However, BO shall align the scope of licence with the scope defined in the latest product manual (PM/15748/3 February 2025) based on the available test reports.**
4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.

5. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment no. 2 and 3 after **29th March 2025 and 23rd June 2025 respectively**.
6. The above guidelines come into force with immediate effect.
