Subject: Guideline for Implementation of revised IS 797:2023 (Common Salt for Chemical Industries)

1. IS 797 : 1982, Specification for Common Salt for Chemical Industries has been revised to IS 797 : 2023, Common Salt for Chemical Industries — Specification.
2. Common Salt for Chemical Industries — Specification as per IS 797 : 2023 is currently under voluntary certification with 3 Licences for the product in operation.
3. IS 797 : 1982 and IS 797 : 2023 are under concurrent running till 28th March 2024 and the last date for implementation of revised IS 797 : 2023 is 28th March 2024
4. The major changes in the standard on account of the revision are given in the table below for the purpose of general guidance:

1.	Page 1, Cl 4.3, Page 2, Table 1 , Sl no iii), iv) & vi)	Alternate instrumental test method for testing of calcium, magnesium and iron by ICP (OES) added
	Page 1, Cl 4.3, Page 2, Table 1, Sl no v)	Alternate instrumental test method for testing of sulphate by Ion Chromatography added

5. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/IS 797/2 Dec 2023.

6. The guidelines for implementation of the revised IS are as given below:

A. LICENSEES:

- (i) The licensee shall implement the revised Indian Standard by 28th March 2024. Any difficulty in implementation shall be brought to the notice of CMD-2 within 30 days from the date of issuance of these guidelines. BO shall ensure that the Licence is not under operation as per IS 797:1982 (old standard) after 28th March 2024. The status of implementation of the revised Indian Standard shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (ii) There is no change in the prescribed requirement. Only instrumental test methods for the determination of calcium, magnesium, iron and sulphates have been added as alternate test methods. Hence, no upgradation in the manufacturing infrastructure is required. Upgradation in the testing infrastructure, if desired by a manufacturer, may be declared in Form no 2.
- (iii) No change in the scope is ensued consequent to the implementation of the revised IS.
- (iv) Verification of implementation of the revised IS, shall be done during next visit.
- (v) If the Licensee fails to complete all actions by 28th March 2024, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard or the revised standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto 28th March 2024. For such cases Applicant shall give a declaration that they will implement the revised Standard by 28th March 2024.
- (iii) Beyond 28th March 2024 no Licence shall be granted as per IS 797: 1982.

7. BOs are requested to circulate this guideline to licensees and applicants immediately within 7 days of issuance of this circular.

8. The above guidelines come into force with immediate effect.
