Subject: Guidelines for implementation of IS 14982 : 2022 Anti-stripping agents for Bitumen addition

1. IS 14982 : 2017 has been revised and published as IS 14982 : 2022. The last date for implementation of the revised Standard is **16 September 2022** after which the old Standard shall stand withdrawn.
2. The changes in the revised Standard as listed in the Table are given for the purpose of general guidance.

Clause	Change
Table 1, Clause 5.2	<ul style="list-style-type: none">- The requirement of solubility in high diesel oil in the ratio of 2 : 98 at ambient temperature has been deleted.- The specified requirement of Wet strength has been corrected as a minimum of 7.50 KN.- The requirement "Stripping value with bitumen containing 1.0 percent of anti-stripping agent" has been renamed as "Retained coating with bitumen containing 1.0 percent of anti-stripping agent".
2	References to the referred Standards have been updated

3. The product Manual is being prepared as per revised standard and would be circulated separately through BIS website.
4. Since the above changes are only editorial and do not require any change in the product or in the testing/manufacturing facilities, no evidence of conformity to the revised standard needs to be obtained from applicants/licensees. However, All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines
5. Beyond 16 September 2022 no Licence shall be granted or kept operative as per the old Standard.
