Subject: Guidelines for implementation of Amendment no. 1 to IS 5295: 2023 (Ethylene Glycol — Specification).

1. Amendment no. 1 to IS 5295: 2023 has been published. The last date of implementation of the amendment is 07 January 2026.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance:

Clause	Change(s)
B-10, Determination of Aldehyde	From the list of Apparatus (B-10.2), Glass Absorber with Connecting Tube and Rotameter for gas flow measurement has been deleted.

3. The deleted apparatus were not being used in the determination of Aldehyde content and have been specified inadvertently in the list of apparatus used. In view of the same, no evidence of conformity for the revised ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.
4. Consequent to the issuance of amendment no. 1, the existing product manual has been revised which is being circulated separately.
5. BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
6. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 07 January 2026.
7. The above guidelines come into force with immediate effect.
