Subject: Guidelines for implementation of revised IS 10613: 2023- Cycles- Safety and Performance requirements for Bicycles for Certificate and Conformity (CoC) as per Bicycles - Retro Reflective Devices (QC) Order, 2023

- 1. Certificates of Conformity under Scheme-IV of BIS (Conformity Assessment) Regulations, 2018 to Bicycle manufacturers are granted in accordance with Bicycles Retro Reflective Devices (QC) Order, 2023 for requirements of retro-reflective devices as per Cl. 4.14 of IS 10613: 2014.
- 2. IS 10613: 2014 has now been revised and published as IS 10613: 2023. The last date for implementation of the revised Standard was 19 May 2023.
- 3. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 4. In the revised standard, the requirements remain same, however the applicable clause number has been changed as Cl. 4.2.2. In view of the above, the scope of the CoC needs to be changed as follows:

Bicycles	- Safety and Performance requirements for Bicycles"

- 5. Consequent upon issuance of the revised Standard, existing Product specific guidelines for grant and operation of CoC has been modified and issued vide Circular No. CMD-3/16: IS 10613/CoC dated 01 June 2023. The Inspection and Testing Plan has also been revised as revised as Doc: ITP/ IS 10613/ 2/ June 2023. In this revision of ITP, clause number and year of Standard has been updated.
- 6. The guidelines for implementation of the revised Standard is given below:

A. Existing CoC holders:

(i) The scope of the existing CoC shall be changed as follows with immediate effect:

reflective devices for	Bicycles as per Clause 4.2.2 of IS 10613: 2023 "Cycles
Bicycles	 Safety and Performance requirements for Bicycles"

(ii) BOs shall inform the Licensees under their jurisdiction about changed scope of their CoC within one week. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of issuance of these guidelines.

B. APPLICATIONS FOR GRANT OF CoC:

- (i) Existing Applications as well as applications which are recorded henceforth shall be processed as per the revised Standard only.
- 7. The above guidelines come into force with immediate effect.
