Subject: Guidelines for implementation of Amendment no. 2 to IS 15138:2010 (Textiles – Jute bags for packing 50 kg sugar – Specification)

1. Amendment no. 2 to IS 15138:2010 has been published. The last date of implementation of the amendment is **30 April 2024**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
<i>Table 2, Sl No. (ii), col (2)</i>	In the Requirements of Packed Bales : 'Number of joined bags per bundle of 25 bags, <i>Max</i> ' has been substituted for 'Number of joined bags per bundle of 25 bags.'
<i>Table 2, Sl No. (ii), col (3)</i>	In addition, the requirement for Number of joined bags per bundle of 25 bags, <i>Max</i> has been reduced from 4 to 1
<i>Table 2, Note</i>	A note has been inserted under table 2 to specify that The number of bags per bundle shall be 25

3. The changes to the standard through this amendment are editorial, none of which require any evidence of conformity to the amended standard to be established.
4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
5. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after **30 April 2024**.
6. The above guidelines come into force with immediate effect.
