Subject: Guidelines for implementation of Amendment No. 1 to IS 8110: 2019 Water well screens and slotted pipes

- 1. Amendment No. 1 to IS 8110: 2019 has been published. The last date for implementation of the amendment is 07 Oct 2022.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

page 1, Clause 2	Referred Standards have been updated
Page 6, Table 3	Dimension (Outer Diameter) of Low Carbon Galvanized (LCG) Screens for well for well depth up to 200 mm has been changed for following nominal sizes- 40 mm, 50 mm
Page 7, Table 5	Dimension (Outer Diameter) of Stainless Steel (SS) Screens for well depth up to 200 mm, has been changed for following nominal sizes- 75 mm, 200 mm, 250 mm
Page 7, Table 6	Dimension (Outer Diameter) of Stainless Steel (SS) Screens for well for well depth up to 450 mm, has been changed for following nominal sizes- 150 mm, 250 mm, 300 mm

- 4. Consequent upon issuance of the amendment, existing Product Manual has been revised as Doc: PM/ IS 8110/ 2/ May 2022. In this revision, number of Amendments to Indian standard has been updated.
- 5. The guidelines for implementation of the amendment is given below:

A. <u>LICENSEES</u>:

- (i) All Licensees shall implement the amendment by 07 October 2022. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per IS 8110: 2019 without Amendment after 07 October 2022. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the modified requirements through Inhouse Test Reports, as applicable for respective varieties. Verification of implementation of the revised Standard, wherever required, may be done during the next visit which may normally be completed within one month from the date of submission of compliance by licensee or latest by three months from the last date of concurrent running.

(iii) If the Licensee fails to complete all actions by 07 October 2022 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only up to 07 October 2022 and for such cases Applicant shall give a declaration that they will implement the amendment by 07 October 2022.
- (iii) Beyond 07 October 2022 no Licence shall be granted without consideration of the amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or up to 07 October 2022 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
