## Subject: Guidelines for Implementation of revised IS 17043 : (Part 1) , Shoes for services, and IS 17043 : (Part 2), Shoes for general purpose

- 1. Derby shoes Specification, IS 17043 : 2018, is under mandatory Certification of BIS. There are currently 4 Licences in operation for the IS.
- 2. IS 17043 : 2018 is intended for shoes used by armed forces/police forces for daily wear and marching. The standard has been revised and is published in following two parts, based on the use of shoes:
  - a) IS 17043 (Part 1):2024, Shoes for services
  - b) IS 17043 (Part 2): 2024, Shoes for general purpose
- 3. On splitting of IS 17043: 2018, IS 17043:2018 is encompassed in IS 17043 (Part 1):2024 whereas IS 17043 (Part 2):2024 is practically a new IS covering general purpose shoes which are the shoes used for formal, semi-formal, casual and other general purposes.
- 4. IS 17043 : 2018 and the split ISs, i.e., IS 17043 (Part 1):2024 and IS 17043 (Part 2):2024 are under concurrent running till 31 July 2024 and the last date for implementation of IS 17043 (Part 1):2024 and IS 17043 (Part 2):2024 is 31 July 2024, after which the old standard (IS 17043 : 2018) shall stand withdrawn.

5. The significant changes in the split and revised IS 17043 (Part 1):2024 in comparison to old IS 17043: 2018, are listed in enclosed Annexure-I, whereas IS 17043 (Part 2):2024 being practically a new Standard, no comparison/changes are drawn.

6. Consequent upon issuance of IS 17043 (Part 1):2024 and IS 17043 (Part 2):2024, product manuals for the respective ISs have been prepared and are being circulated separately through BIS website as Doc: PM/IS 17043 (Part 1)/4 Feb 2024 and Doc: PM/IS 17043 (Part 2)/1 Feb 2024

7. The guidelines for implementation of IS 17043 (Part 1):2024 and IS 17043 (Part 2):2024 are given below:

### A. <u>LICENSEES:</u>

### a) <u>Switchover to IS 17043 (Part 1) : 2024</u>

i. The existing Licence shall be switched over to IS 17043 (Part 1) : 2024. The licencee shall submit evidence of conformity against the new IS through In- house and/or Independent Test Reports as per IS 17043 (Part 1) : 2024.

- ii. Licencee shall submit declaration for additional Testing equipment in Form no 2 as applicable, if testing of the parameter is done inhouse or submit details of arrangement for testing of the parameters from Independent lab (Subcontracting of the tests), in accordance with the Scheme of Inspection and testing/QAP defined. (Not applicable for Micro and small-scale units who have availed exemption from in-house testing)
- iii. BOs shall align scope of the licence as per PM of 17043 (Part 1) : 2024 based on the documents submitted and available Test reports, and issue endorsement accordingly on switchover to IS 17043 (Part 1) : 2024.
- b) For IS 17043 (Part 2) : 2024, all manufacturers are required to obtain a new Licence against the IS. The applications received for the IS shall be treated as a new application and shall be processed as per the extant GOL Guidelines.
- c) Any difficulty in switchover shall be brought to the notice of CMD-2 immediately after issuance of these guidelines. BOs shall ensure that the Licence is not under operation as per IS 17043: 2018 (old standard) after 31<sup>st</sup> July 2024. The status of switchover of the IS 17043 (Part 1) : 2024 shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of concurrent running.
- **d)** Verification of implementation of IS 17043 (Part 1) : 2024, shall be done through a surveillance visit preferably within 30 days of confirmation of implementation of the standard by licensee.
- e) If the Licensee fails to complete all actions by 31 July 2024, it shall be dealt with as per the prevailing guidelines.

### B. APPLICATIONS FOR GRANT OF LICENCE:

- a) Existing Applications for GOL where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard i.e. IS 17043: 2018. A declaration may be obtained from the Applicant that the Licence, if granted shall be switched over to IS 17043 (Part 1) : 2024 before the last date of concurrent running of the ISs. BOs shall ensure that such licenses granted are switched over to IS 17043 (Part 1) : 2024 before the last date of withdrawal of IS 17043: 2018, i.e., 31st July 2024. If, however, the Applicant is desirous of considering the Application as per IS 17043 (Part 1) : 2024, a declaration may be obtained from the Applicant to the effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails considering IS 17043 (Part 1) : 2024, Licence will not be granted by BIS as per IS 17043: 2018.
- b) Applications which are recorded henceforth may be processed as per IS 17043: 2018/ IS 17043 (Part 1): 2024/ IS 17043 (Part 2): 2024. Processing of Applications as per the old Standard, shall be permitted only upto 31 July 2024. For such cases, Applicant shall give a declaration that they will switchover to IS 17043 (Part 1): 2024 by 31 July 2024.
- c) Beyond 31 July 2024, no Licence shall be granted as per IS 17043: 2018.

#### C. CHANGE IN SCOPE OF LICENCE:

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of switchover to the IS 17043 (Part 1) : 2024.
- 8. BOs are requested to circulate this guideline to licensees and applicants immediately within 7 days of issuance of this circular.
- 9. The above guidelines come into force with immediate effect.
