- 1. Amendment No. 1 to IS 1848 (Part 1): 2018 has been published. The amendment shall be implemented with immediate effect.
- 2. The changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause	Change
Page 2, clause 5.2 c of Marking	First sentence of clause 5.2 c has been substituted. Now mass of 500 sheets including wrapping paper, in kg/ream or 250 sheets including wrapping paper, in kg/packet can be marked.
Page 3, Table 1	Existing table has been replaced with new table. There is no change in the requirements of writing and printing papers, only test method Standards have been updated in the table.

- 3. The existing Product Manual is being revised and would be circulated separately through BIS website.
- 4. Since there is no change in the requirement of the standard through this amendment and only minor changes in the standard through this amendment which do not require any change in the product or in the testing/manufacturing facilities, no evidence of conformity to the amendment needs to be obtained from applicants/licensees.
