**Subject: Guidelines for implementation of Revised IS 573:2023 (Trisodium Phosphate — Specification)**

1. IS 573:1992 has been revised as IS 573:2023 and has been published. The last date for implementation of the revised Standard is **2 Feb 2024** after which the old Standard shall stand withdrawn.
2. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Change
2, Annex A	Instrumental test methods for the determination of arsenic, chlorides, lead and sulphates have been added as alternate test methods
6	Packing and Marking clause has been updated.

3. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately.
4. Since there are no substantive changes to the standard except the addition of alternate test methods, no evidence of conformity to the revised standard in the form of test report etc. needs to be submitted by licensees/applicants.
5. However, All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines and seek confirmation of implementation of the revised standard. Upon receipt of positive confirmation, licenses and applications shall be switched over to the revised standard.
6. However, no application as per the old standard shall be accepted and no licence permitted to be operative as per the old standard after **2 Feb 2024**.
7. The above guidelines come into force with immediate effect.
