Subject: Guidelines for implementation of Amendment No. 1 to Indian standard IS 17566: 2021- Key Locks for Security Equipment

- 1. Amendment No. 1 to IS 17566: 2021 has been published. The last date for implementation of the Amendment is **01 February 2024**.
- 2. BOs shall inform the Licensee under their jurisdiction about implementation of the Amendment within a week of issuance of these guidelines and hold meeting with Licensee (Physical or virtual) to make them understood the compliance requirements required to implement the Revised standard.
- **3.** The significant changes brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BO shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

- 4. Consequent upon issuance of the Amendment, existing Product Manual has been revised as Doc: PM/ IS 17566/ 3/ September 2023. In this revision, changes have been made in requirements of raw material, Grouping Guidelines and Scheme of Inspection and testing.
- 5. The guidelines for implementation of the Amendment is given below:

A. LICENSEES:

(i) Licensee shall implement the Amendment by 01 February 2024. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BO shall ensure that no Licences are under operation without Amendment after 01 February 2024. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

- (ii) In order to establish conformity to modified requirements, Licensee shall submit in-house test report of product (for Lever type lock covered in scope of licence), as evidence of conformity to the Amendment.
- (iii) Further, in view of revision of Grouping Guidelines, factory test report of all other varieties which were NOT tested at the time of GoL/CSoL in presence of BIS, shall also be submitted by the licensee manufacturer.
- (iv) Verification of implementation of the Amendment, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee. During verification visit, in addition to verification of modified requirements as per the Amendment, samples of all such varieties which were NOT tested in presence of BIS at the time of GoL/CSoL, shall also be tested for all possible tests in a day. Licensee shall be informed to prepare the samples of such varieties for verification visit.
- (v) If the Licensee fails to complete all actions by 01 February 2024, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been tested may be processed without considering Amendment. However, if the Applicant is desirous of considering the application with Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, Licence will not be granted without Amendment.
- (ii) Applications which are recorded henceforth may be processed with or without Amendment. Processing of Applications without Amendment shall be permitted only up to 01 February 2024 and for such cases Applicant shall give a declaration that they will implement the Amendment by 01 February 2024.
- (iii) Beyond 01 February 2024 no Licence shall be granted without consideration of the Amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 01 February 2024 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
