Subject: Guidelines for implementation of revised IS 12234:2021 - ‘Plastic Equilibrium Float Valves for Cold Water Services’

1. IS 12234:1988 has been revised as IS 12234:2021 and has been published. The last date for implementation of the revised Standard is **29 June 2022** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard **within a week of issuance of these guidelines**.
3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Requirement
3.2	Provisions on pressure reducing attachments have been modified. High pressure and low pressure categorization has been removed in pressure reducing attachment
5.1	Materials for inlet float valves have been updated considering the current manufacturing practices
7.1.1	Provisions have been updated to cover inlet valves for concealed cisterns
7.9	Prevalent float design has been incorporated considering that spherical floats which were more suitable for single flush cisterns do not find much application in the current scenario
7.1.2	Vertical inlet shank float valve of adjustable height have been introduced
10	Additional marking requirements specified

4. Consequent upon the issuance of the revised Standard, existing SIT in the Product Manual has been revised and included in the revised Product Manual Doc: **PM/IS 12234/2/Apr 2022**.
5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- (i) All Licensees shall implement the revised Standard by **29 June 2022**. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case, at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per the old Standard after 29 June 2022. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable.

Verification of implementation of the revised Standard may be done during the next visit, which may normally be completed within three months of the last date of concurrent running.

- (iii) As Provisions on pressure reducing attachments have been modified which includes deletion of categorization of pressure reducing attachment as High Pressure and Low Pressure Reducer, the scope of existing licensees may be reviewed and endorsements may be issued accordingly.
- (iv) If the Licensee fails to complete all actions by **29 June 2022**, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **29 June 2022** and for such cases, Applicant shall give a declaration that they will implement the revised Standard by **29 June 2022**.
- (iii) Beyond **29 June 2022** no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
 - (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **29 June 2022** whichever is earlier.
6. The above guidelines come into force with immediate effect.
