Subject: Guidelines for implementation of revised Indian Standard IS 15627: 2022-Automotive Vehicles- Pneumatic Tyres for Two and Three Wheeled Motor Vehicles, Quadricycles, E-Rickshaw/E-Carts

- 1. IS 15627: 2005 has been revised and published as IS 15627: 2022. The last date for implementation of the revised Standard is **25 March 2023**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- **3.** The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Apart from the above changes, some of the tyre size designations which are not in regular production have been removed from the relevant Tables in the revised Standard (e.g. 90/90-10 and 100/90-10 have been removed from Table 8- Scooter/Motor cycle tyres, tyre

size designations of 100 series have been removed from Table 8- Scooter/Motor cycle tyres). However, the same may still be covered against the declarations of the manufacturer as per Cl. 6.3 of IS 15627: 2022 and therefore it may not be required to delete these varieties from scope of licences, if the licensee wishes to continue with these varieties.

- 4. Consequent upon revision of the Standard, existing Product Manual has been revised as Doc: PM/ IS 15627/ 4/ May 2022. In this revision, Table Nos. in SIT have been updated and 'Intended for use on (Type of Vehicle)' has been added as an additional parameter in scope of licence.
- 5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- (i) All Licensees shall implement the revised Standard by 25 March 2023. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case, at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation Standard as per old Standard after 25 March 2023. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Consequent upon revision of the standard, new size designations of tyres have been added in the scope of the Standard. As per the provisions in the old Standard, Tyres whose size designations are not covered in the Standard, could also be approved against the specification declared by the manufacturer as per Old standard. Therefore, it is possible that the size designations which are being added now in the revised Standard, may already be covered under scope of some of the licences. However, for those size designations, it will be required to verify that the declared specifications are in line with the specifications given in the revised Standard. If any deviation is observed in these specifications, then the licensees will be required to re-submit specification of these size designations as per the revised Standard and submit evidence of conformity of these size designations to the revised Standard in form of in-house test reports/independent test reports, as applicable.
- (iii) Therefore, in order to establish conformity of products of those size designations, BOs shall examine whether the declared specifications of those size designations are in line with the specifications given in the revised Standard or not. If any deviation is observed in these specifications, then the licensees shall be advised to re-submit specification of these size designations as per the revised Standard and to submit evidence of conformity of these size designations to the revised Standard in form of in-house test reports/independent test reports, as applicable.
- (iv) Based on the above assessment, wherever required, Licensee shall submit fresh declarations and in-house factory test report/independent test reports, as applicable.
- (v) Further, since "Intended for use on (Type of Vehicle)" has been added as an additional parameter in the scope of licence, the scope of all the licences will have to be reviewed for all the existing varieties and be revised as per the new Standard for which fresh declaration will have to be submitted along with test reports and the same will have to be evaluated by BOs. Scope of all licences will be revised based on the above assessment.

- (vi) Verification of implementation of the revised Standard, wherever required, may be done during the next visit which may normally be completed within one month from the date of submission of compliance by licensee or latest by three months from the last date of concurrent running.
- (vii) If the Licensee fails to complete all actions by 25 March 2023 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per old Standard. However, if the Applicant is desirous of considering the application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised Standard, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per old or revised Standard. Processing of Applications as per the old Standard shall be permitted only up to 25 March 2023 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 25 March 2023.
- (iii) Beyond 25 March 2023 no Licence shall be granted as per Old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per old Standard shall be permitted only upto the date of implementation of the revision by the licensee or up to 25 March 2023 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
