Subject: Guidelines for implementation of amendment no. 2 to IS 17450: 2020 (1,3 Phenylenediamine - Specification).

1. Amendment no. 2 to IS 17450: 2020 has been published. The last date of implementation of the amendment is **02 September 2026**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause	Change
Page 3, clause A-5, line 3	Substitute 'acetonitrile' for 'acetone'
Page 3, clause A-5, line 7	Substitute 'acetonitrile' for 'acetone'
Page 3, clause A-5, line 11	Substitute 'acetonitrile' for 'acetone'
Page 3, clause A-6, line 2	Substitute 'acetonitrile' for 'acetone'
Page 3, clause A-6, line 3	Substitute 'acetonitrile' for 'acetone'

3. The revision does not involve any major change in product requirements, testing infrastructure or test methodology affecting conformity assessment. Hence, no additional evidence of conformity is required to establish implementation of this Amendment.
4. Consequent upon the issuance of the Amendment No. 2, the existing Product Manual does not require technical revision; however, it has been aligned with the latest template (**PM/ 17450/ 2 July 2026**).
5. In view of the above, BOs are requested to circulate to licensees and applicants immediately within 7 days of issue of this circular.
6. All licensees shall ensure implementation of **amendment no. 2 to IS 17450: 2020** by 02 September 2026.
7. The above guidelines come into force with immediate effect.
