Subject: Guidelines for implementation of Revised IS 8074:2024 (Monocrotophos, Soluble Concentrate (SL) — Specification)

- 1. This has reference to the above.
- 2. IS 8074:1990 has been revised as IS 8074:2024 and the date of withdrawal of IS 8074:1990 is **09**<sup>th</sup> **April 2025**.
- 3. Presently, for IS 8074:1990, 01 licences is operative domestically under SUBO.
- 4. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause(s) as per IS 8074:2024	Change
	The standard has been brought out in the latest style and format of the Indian Standards as well as references to Indian Standards wherever applicable have been updated. It also incorporates two amendments issued to the previous version of this standard.
	A new clause listing the referred standards has been added and subsequent clauses have been renumbered. Further, the latest versions of the referred standards have been updated

- 5. Consequent upon the issuance of the revised Standard, the existing product manual of IS 8074 has been revised which is being circulated separately.
- 6. The guidelines for implementation of the revised Standard is given below:

#### A. LICENSEES:

- i) Licensee under SUBO shall implement the revised Standard by **09**<sup>th</sup> **April 2025.** Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest but in any case at least 30 days before the last date of implementation. SUBO shall ensure that the Licence shall not remain in operation as per old Standard after **09**<sup>th</sup> **April 2025**. The status of implementation of the revised Standard shall be confirmed by Head (SUBO) to CMD-2 within two weeks of the last date of concurrent running.
- ii) As per the changes introduced into the standard through the revision, there are no evidences of conformity required to be submitted by the licensee.
- iii) Earlier no Grouping Guidelines were prescribed. In the revised Product Manual of IS 8074, Grouping Guidelines based upon nominal Monocrotophos content (percent by mass) in Monocrotophos, Soluble Concentrate (SL) have been specified and range of Monocrotophos content (percent by mass) in Monocrotophos, Soluble Concentrate (SL) has been added as a part of Scope of Licence.

- iv) Licensee under SUBO shall declare the range of Monocrotophos content (percent by mass) in Monocrotophos, Soluble Concentrate (SL) being manufactured by them and submit in-house test reports as per Grouping Guidelines.
- v) SUBO shall revise the scope of licence based upon declaration of range of Monocrotophos content (percent by mass) in Monocrotophos, Soluble Concentrate (SL) submitted by the firm and issue endorsement for revised scope of licence along with switchover to revised IS 8074:2024.

#### B. APPLICATIONS FOR GRANT OF LICENCE:

- 1. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- 2. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 08<sup>th</sup> April 2025 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 09<sup>th</sup> April 2025.
- 3. Beyond **09**<sup>th</sup> **April 2025** no Licence shall be granted as per the old Standard.

#### C. CHANGE IN SCOPE OF LICENCE:

- 1. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to 09<sup>th</sup> April 2025 whichever is earlier.
- 3. The above guidelines come into force with immediate effect.
