Subject: Guidelines for implementation of Amendment no. 2 to IS 10702 : 2023, HAWAI CHAPPAL — SPECIFICATION.

1. Amendment no. 2 to IS 10702 : 2023 have been published.
2. The product is under mandatory certification. There are 116 licences for the product and no applications for GOL in India.
3. IS 10702 : 2023 with and without amendment No. 02 are under concurrent running till 2nd April 2026 and the last date for implementation of amendment is 2nd April 2026.
4. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Major Changes due to amendment no 2 to IS 10702 : 2023

Sl no	Clause No	Change
1.	Page 1, clause 4	Clarification on categorization of kids and adult sizes has been made based on last length. It is further clarified in the note that <i>categorization is only for the purpose of differentiation between adults and kids and not for the purpose of defining sizes</i>
2.	Page 2 & Table 1	A new requirement “Slip resistance” (applicable for Type 1 and non-leather sole, hawai chappal) has been added.
3.	Page 3 & Table 2	It has been clarified for strap also that the requirement for lead content is applicable for PVC only.
4.	Page 3, Cl.5	Chemical requirement is part of table 1 and 2 (introduced in amendment no 1). Separate redundant clause for chemical requirement of Hawai Chappal has now been deleted.
5.	C-2.6 & 2.7	Editorial correction has been made in the formula in the test method of density. (the requirement though is not applicable on Hawai chappal)

5. The existing Product manual has been revised to incorporate the changes due to the amendment to the IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/10702/4 January 2026

6. The guidelines for implementation of amendment 2 to the IS are as given below:

A. LICENSEES:

- a) Any difficulty in implementation shall be brought to the notice of CMD-2 immediately after issuance of these guidelines. BO shall ensure that Licence is not under operation without consideration of amendment no 2 to the IS after 02 April 2026. The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation.
- b) In the amendment, requirement for slip resistance has been introduced for Type 1 hawai chappal with non-leather sole. Clarification on the categorization of sizes, applicability of Lead content test on straps have been given.

- c) Licensee shall submit evidence of conformity for Type 1 (with non-leather sole) hawai chappal, if covered in the scope of Licence, and shall submit declaration for additional Testing equipment in Form no 2 as applicable, if testing of the new parameter is done in-house or submit details of arrangement for testing of the parameter from independent lab (Subcontracting of the tests), in accordance with the Scheme of Inspection and testing/QAP submitted by manufacturer. [SME units exempted as per Cl 5 of SIT].
- d) Verification of implementation of amendment to the IS, shall be done through a surveillance visit preferably within 30 days of confirmation of implementation of the amendment to the standard by licensee.
- e) If the Licensee fails to complete all actions by 02 April 2026, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- a) Existing Applications for GOL where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the IS with/without the amendment. If the Applicant is desirous of considering the Application, with the amendment to the IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the IS incorporating the amendment, Licence will not be granted by BIS without considering the amendment.
- b) Applications which are recorded henceforth may be processed with or without considering Amendment no 2 to the IS. Processing of Applications without considering the amendment, shall be permitted only upto 01 April 2026. For such cases Applicant shall give a declaration that they will implement the amendment by 02 April 2026.
- c) Beyond 02 April 2026, no Licence shall be granted without considering the amendment.

C. CHANGE IN SCOPE OF LICENCE:

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard.
- 7. BOs are requested to circulate this guideline to licensees and applicants immediately within 7 days of issuance of this circular.
- 8. The above guidelines come into force with immediate effect.
