Subject: Guidelines for implementation of Amendment No. 3 to IS 302-2-30 : 2007 'SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES PART 2 PARTICULAR REQUIREMENTS SECTION 30 ROOM HEATERS (First Revision)'

- 1. Amendment No. 3 has been published for IS 302-2-30 : 2007 'SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES PART 2 PARTICULAR REQUIREMENTS SECTION 30 ROOM HEATERS (First Revision)'. The last date of concurrent running of IS 302-2-30 : 2007 with and without Amendment No. 3 is **08** February 2024.
- 2. Currently there are 93 licences and 2 applications for the product. In this regard, the concerned branch Offices, shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. Any difficulty in the implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines.
- 4. The significant changes brought in the Indian Standard through the Amendment listed in the Table below. All the concerned BOs are requested to ensure the compliance of the requirements as specified in the amended Indian Standard.

- 5. Further, changes have been made in levels of control in Scheme of Inspection & Testing for the Indian Standard 'Marking 'has been added in possible tests in a day.
- 6. In view of these, the Product Manual for the Indian Standard has been modified as '**PM/IS** 302-2-30/4/December 2023'.
- 7. The guidelines for implementation of the Amendment is given below:

A. For Licensees:

- (i) In order to establish conformity to modified requirements, licensees shall submit the evidence of compliance/conformity to requirements of the Amendment 3 to IS 302-2-30 : 2007. The same may be verified by BIS through Factory Surveillance and Market Surveillance. A declaration regarding the same may also be taken in this regard.
- (ii) BOs shall ensure that no Licences are under operation without the implementation of the Amendment No. 3 after 08 February 2024.
- (iii) If the Licensee fails to complete all actions by 08 February 2024, necessary actions may be initiated.

B. For Applicants:

- (i) Currently, there are 2 applications as per IS 302-2-30 : 2007.
- (ii) Applications under process and applications which are recorded henceforth may be processed with or without consideration of the amendment no. 3.
- (iii) Processing of Applications without consideration of the amendment no. 3 shall be permitted only upto 08 February 2024 and for such cases Applicant shall give a declaration that they will implement the amendment by 08 February 2024.

C. For Inclusions:

- (i) Existing provisions for Application shall apply.
- 8. The above guidelines come into force with immediate effect.
