Subject: Guidelines for implementation of Revised IS 3899:2024 (Zineb Water Dispersible Powder — Specification)

- 1. IS 3899:1981 has been revised as IS 3899:2024 and has been published. The last date for implementation of the revised Standard is **15 Sept 2024** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately through BIS website.
- 5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- i. The licensee shall implement the revised Standard by 15 Sept 2024. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest. BOs shall ensure that no Licences are under operation as per the old Standard after 15 Sept 2024. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.
- ii. Since there are no technical changes to the standard due to the revision, existing licensees need not submit any evidence of conformity to the revised standard.
- iii. The licensees shall confirm implementation of the revised standard in writing to the BIS Branch Office. Upon receipt of said confirmation, the license shall be changed over to the revised standard by BIS Branch Office.
- iv. If the Licensee fails to complete all actions by **15 Sept 2024** it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the revised standard since there are no technical changes due to the revision which require conformity of the product to be re-established.

- ii. Applications which are recorded henceforth may be processed as per the revised Standard.
- iii. Henceforth, no Licence shall be granted as per the old Standard.
- 6. The above guidelines come into force with immediate effect.
