Subject: Guidelines for implementation of Amendment no. 1 to IS 11657 : 2020 (Phosphorus oxychloride, Technical - Specification)

- 1. Amendment no. 1 to IS **11657 : 2020** has been published.
- 2. Specification for **Phosphorus oxychloride**, **Technical** as per IS **11657** : **2020** is currently under mandatory certification with 2 licences in operation, one each in SUBO and VDBO under WRO.
- 3. The concurrent running period for IS 11657 : 2020, with and without Amendment no 1 is 26 May 2023.
- 4. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause	Change
Table 1, Sl. No.	Maximum limit for Arsenic has been increased from 0.000002
(iv) Arsenic	to 0.0002 (percentage by mass)

- 5. There is no change in the prescribed test method with this amendment, only the limit for Arsenic has been relaxed. Hence, there is no up gradation required in the manufacturing and/or in the testing set up of the manufacturer.
- 6. BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issuance of this circular.
- 7. There is no change required in the existing Product manual on account of the amendment.
