Subject: Guidelines for implementation of Amendment No. 1 to IS 3614:2021 – Fire Doors and Doorsets

- 1. Amendment No. 1 to IS 3614:2021 has been published. The last date for implementation of the amendment was **02 Jan 2024**.
- 2. The change brought out in the Standard through the amendment is listed in the Table:

Clause	Requirement
4.1	Test method Standard for fire resistance test has been modified from IS/ISO 3008-1 to IS 17518 (Part 1)
5.2 & 5.3 Table 1	Classification of fire doors as well as designations have been modified
7.2.9	The fire rating and labelling criteria of hardwares in Clause 7.2.9 para-line 1 & line 11, Clause 7.2.9 para 5-line 11 have been modified from 'shall' to 'should'
7.3.2	Sizes of hinged wooden composite fire door have been widened.

- 3. Consequent upon the issuance of the amendment, existing Product Manual has been revised as Product Manual, Doc: PM/IS 3614/2/Nov 2023 to incorporate the modified fire door classification system in the scope of licence and grouping guidelines.
- 4. The amendment does not require any action by the applicants/ licensees towards its implementation.
- 5. As the fire door classification (rating and insulation) has been modified, accordingly the scope of existing licensees may be reviewed and endorsements may be issued; after obtaining fresh drawing of the Fire Doors and Doorsets as per the modified door classification system in accordance with the grouping guidelines, from the manufacturer.
- 6. All BOs shall inform the Applicants and Licensees under their jurisdiction about the above amendment immediately.
- 7. The above guidelines come into force with immediate effect.
