Subject: Guidelines for implementation of amendment no. 1 to IS 17077 :2022, Plastics — Acrylonitrile Butadienestyrene (ABS) Moulding and Extrusion Materials

1. Amendment No. 1 to IS 17077 :2022 has been published with last date of implementation as 19 September 2025.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
Page 4, Table 3, Note 2, line 5	Substitute 'MH 05 Fe' for 'MEH 05 Fe'.

3. Through this amendment only editorial changes have been made in example given for Code-Letters for Fillers and Reinforcing Materials in Data Block 3.
4. Since there are no changes in the requirement specified, no evidence of conformity for amendment no. 1 to the ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.
5. BOs are requested to circulate this amendment to all the licensees and applicants for information.
6. No modification in the existing product manual is required consequent upon the issuance of the amendment to Standard.
7. The above guidelines shall come into force with immediate effect.
