- 1. IS 444: 2017/ISO 1403: 2005 has been revised as IS 444: 2025/ISO 1403: 2019 and has been published. The last date for implementation of the revised Standard is 22th October 2025 after which the old Standard shall stand withdrawn.
- 2. This revision has been brought out to align with the latest version of ISO 1403: 2019. The significant changes in the standard through this revision as listed in the Table are given for the purpose of general guidance.
