- <u>Subject</u>: Guidelines for implementation of Amendment No. 1 to IS 1783 (Part 1): 2014 'Drums Large, Fixed Ends Specification Part 1 Grade A Drums'
- 1. Amendment No. 1 has been notified for IS 1783 (Part 1): 2014 'Drums Large, Fixed Ends Specification Part 1 Grade A Drums'. The last date of concurrent running of the Standard with and without Amendment No. 1 is 15th December 2023.
- 2. The significant changes brought through this Amendment as listed in the Table below:

Cl. 2	Referred Standards (IS 513 & IS 1784) have been updated
Cl. 6	Referred Standard IS 513 has been updated
9.2.3	'Applicable for Grade A, Type 1 only' has been deleted i.e.
	now the test is applicable for both Type 1 & Type 2 drums

- 3. Consequent upon issuance of the amendment, the Product Manual has been revised as Product manual Doc: PM/ IS 1783 (Part 1)/ 2/ September 2023 and is being circulated separately through BIS website.
- 4. The guidelines for implementation of the Amendment is given below:

A) LICENSEES

- i. Licensees having licence for Type 2 drums shall submit in-house test report / test report from BIS approved third party laboratory of product in order to establish conformity to the modified requirements.
- ii. Licensee shall implement the Amendment by 15th December 2023. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BO shall ensure that no Licences are under operation without Amendment after 15th December 2023. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- iii. Verification of implementation of the Amendment No. 1 to IS 1783 (Part 1): 2014 shall be done through a surveillance visit, which shall be completed within one months from the last date of implementation.
- iv. If the Licensee fails to complete all actions by 15th December 2023, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant desires to get the licence with the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- ii. Applications which are recorded henceforth may be processed with or without Amendment. Processing of Applications without Amendment shall be permitted only up to 15th December 2023 and for such cases Applicant shall give a declaration that they will implement the Amendment by 15th December 2023.
- iii. After 15 December 2023, no Licence shall be granted without consideration of the Amendment.
 - 5. The above guidelines come into force with immediate effect.
