**Subject: Guidelines for implementation of Amendment No. 1 to IS 16988: 2018-Compressed Natural Gas Cylinder Valve Integrated with Solenoid Operation (Remotely Controlled) for Automotive Use**

1. Amendment No. 1 to IS 16988: 2018 has been published. The last date for implementation of the amendment is 20 May 2022.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment within **a week of issuance of these guidelines**.
3. The significant changes in the Standard being brought through the Amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.
