- 1. IS 4658:2019 is under voluntary certification with 03 licences in operation domestically.
- 2. Amendment no. 1 to IS 4658:2019 has been published. The amendment shall be implemented with effect from **01**st **February 2024**.
- 3. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 4. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.
