### **Subject: Guidelines for implementation of Amendment No. 1 to IS 7872: 2020- Deep Freezers**

1. Amendment No. 1 to IS 7872: 2020 has been published. The last date for implementation of the Amendment is 23 July 2022.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the Standard brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Changes Incorporated
Foreword, Para 3	Major changes in the Standard while revision (from 2018 to 2020) have been indicated
Page 4, Cl. 5.4.1	It has been clarified that compliance to strength pressure test can be done by any one of the tests specified in Cl. 5.4.2 to Cl. 5.4.4.
Page 5, Cl. 7, Para 1	Note has been added to specify that for in case of any deviation in limit of sound pressure level set in ISS and that set out in the Noise Pollution (Regulation and Control) Rules, the limits given in the Noise Pollution (Regulation and Control) Rules shall prevail
Page 9, Cl. 11.3	Acceptance criteria for Temperature rise test has now been specified which was not specified earlier
Page 9, Cl. 11.5	Editorial correction has been done to specify the acceptable limit of deflection

4. Consequent upon issuance of the Amendment, existing Product Manual has been revised as Doc: PM/ IS 7872/ 3/ February 2022. In this revision of Product Manual, changes have been made in Scheme of Inspection and Testing (Table 1- Strength pressure test).
5. The guidelines for implementation of the amendment is given below:

#### **A. LICENSEES:**

- (i) All Licensees shall implement the amendment by 23 July 2022. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation Standard without Amendment after 23 July 2022. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Report, as applicable.
- (iii) Verification of implementation of the Amendment, wherever required, may be done during the next visit **which may normally be completed within one month from the date of submission of compliance by licensee or latest by three months from the last date of concurrent running.**
- (iv) If the Licensee fails to complete all actions by 23 July 2022 it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the Amendment. However, if the Applicant is desirous of considering the application with Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted without the Amendment.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the Amendment. Processing of Applications without consideration of the Amendment shall be permitted only up to 23 July 2022 and for such cases Applicant shall give a declaration that they will implement the amendment by 23 July 2022.
- (iii) Beyond 23 July 2022 no Licence shall be granted without consideration of the amendment.

**C. CHANGE IN SCOPE OF LICENCE:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the Amendment shall be permitted only upto the date of implementation of the amendment by the licensee or up to 23 July 2022 whichever is earlier.

6. The above guidelines come into force with immediate effect.
